Mr. Bellows called the meeting to order at 7:00 p.m.

VIRGINIA DEPARTMENT OF TRANSPORTATION

Mr. David Brown, the Northern Neck Residency Administrator, stated that the department has been working on ditch maintenance, cutting back vegetation, repairing potholes and preparing for possible snow removal.

Mr. Brown stated that he would like to update the Board on the Merry Point Ferry. He stated that they have a service maintenance contract for the ferries at Merry Point and Sunnybank in Northumberland County. He stated that this time of the year has the lowest ridership and thus is, a good time for maintenance. He stated that the ferries that are in operation now were put into service in 2010. He stated that the maintenance included the inspection of the hulls, taking care of any corrosion, sandblasting, painting and any other mechanical work deemed necessary. He stated that this work should be done about every three to four years. He stated that the Sunnybank Ferry is currently in dry dock and after its work is completed, it will come to the Merry Point location and the ferries will be switched.

Mr. Brown asked if there were any issues that the Board had for him or Mr. Harper.

Mr. Lee stated that there was a big pothole at the intersection of Harris Road (Route 1036) and Mary Ball Road (Route 3).

Mr. Harper stated that he was aware of the issue and the repair is on their list.

Mr. Bellows asked about the painting of the Robert O. Norris Bridge.

Mr. Brown replied that he had not received any information on that project. He stated that the Norris Bridge is one of the larger structures in the area and it was his understanding that VDOT is looking to separate the funding for larger jobs, such as bridge and tunnel maintenance from the regular maintenance funding.

Mr. Bellows stated that there is still a drainage issue on Ocran Road (Route 646) and Cardinal Lane (Route 793).

Mr. Harper stated that he would take care of that issue.

Mr. Beauchamp asked about the four-year ferry maintenance schedule.

Mr. Brown replied that they would like to have them maintained about every three to four years and this was the first opportunity they had. He stated that they are looking at the possibly of making it a two-year cycle, based upon what they are seeing this time.

Mr. Pleva stated that Steve Parker, the Lancaster County Schools Superintendent, was present at the meeting, if the Board had any questions of him. He referred to a revised memorandum from Whitney Barrack, the Director of Finance for Lancaster Schools, and stated that the total amount of revenue and the total amount of expenditures is \$82,500. He stated that the change is that the school is requesting that the insurance claim check they have received for \$119,791 be allocated to a Capital Improvement Fund for construction of the new athletic facility at the high school.

3. <u>FY 15 School Budget Request to Create an Additional "Textbook" Fund</u> <u>Category for Carryover State Aid for Textbooks</u> Mr. Pleva stated that the General Assembly's adopted budget encouraged that any unexpended textbook funds be put into a textbook fund account and not revert back to the general fund. He stated those funds would then be available for future fiscal year textbook purchases.

Mr. Bellows stated that he did not see a dollar amount and asked if the school was asking for any monies at this time.

Mr. Parker replied that their request is that they be able to set up the fund now and take any unexpended funds from this year and place them into the fund. He stated that the schools' budget request for the upcoming fiscal year will include a request for funding the textbook account. He stated that this will give them greater purchasing power. He stated that they will be able to buy more when they can carry funds over.

Mr. Bellows stated that it is a way for the school system to save some money because they will be able to buy textbooks in bulk.

COUNTY ADMINISTRATOR

Mr. Pleva stated that at next month's regular meeting there will be a public hearing conducted concerning an utility easement for Dominion Virginia Power. He stated that the public hearing is necessary because an interest in real estate is being conveyed. He further stated that the General Assembly has directed Dominion Virginia Power to bury, over the next ten years, 58,000 miles of overhead power lines to reduce outages. He stated that one of those lines is going across the County's convenience center off of Regina Road (Route 604).

Mr. Pleva stated that he had polled the members of the boat tax committee, including the Board of Supervisors and the citizen members and the next boat tax meeting will be held on Tuesday, February 17th at 6:00 p.m.

Mr. Pleva stated that the school board anticipates approving their draft budget proposal for the Board of Supervisor's consideration on Monday, February 9th. There was some discussion of when the Board of Supervisors and the school board would meet for a budget work session. The consensus was to have the budget work session scheduled for Monday, February 23rd at 5:00 p.m.
