FY08 Revenue

Mr. Thomas, Commissioner of the Revenue, said expected revenue projections would be an increase of \$35 - \$40 million in assessed property values over last year. Wal-Mart will pay \$3,000 in real estate taxes for land only and next year Wal-Mart expected to do business \$1 - \$1.25 million range with an estimated \$8 million in real estate and improvement values.

Mr. Thomas said farm annuals are very difficult to assess and the county receives very little tax funding from farm machinery.

Mr. Thomas stated there are about 40 elderly/disabled who take advantage of the reduced real estate taxes on these citizens.

Mr. Thomas said the general reassessment currently underway will be effective in the tax bills receive on December 5, 2008.

Lancaster School FY08 Budget

There was some discussion by the Board of Supervisors and they gave their personal overview on the school budget.

Mr. Pennell presented a chart showing what a 3% increase in the school budget would cost.
