VIRGINIA DEPARTMENT OF TRANSPORTATION

Mr. Pennell stated Sean Trapani was unable to attend the meeting, however; he provided an email with a few details of work in progress.

Mr. Pennell said VDOT would be closed Friday, May 28, 2010 for the mandatory state employee furlough and Monday, May 31, 2010 for Memorial Day, however; they would be available for emergencies.

Mr. Pennell provided the Board of Supervisors with the following information given by Mr. Trapani in an email:

Mr. Trapani stated Robert Harper has an agreement with the property owner on Millenbeck Road that they will do the tree trimming and Mr. Harper is tracking the progress.

Mr. Trapani said patching is being performed throughout the county by both VDOT and contractors. There will be street sweeping done in the towns next week.

There was a pipe failure on VSH 674/Woods Drive and they are developing a contract for repairs.

The primary highways mowing should begin the end of June.

They are aware of some issues at the ferry and working through them. The engine keeps overheating and cutting off and there are ramp issues. The boat builder and the engine manufacturer are supposed to be working on the ferry the Memorial Day weekend.

PUBLIC HEARING

1. <u>FY2011 Lancaster County Operating Budget</u> – Mr. Larson present a synopsis of the proposed FY 2011 County Operating Budget as the Board of Supervisors has developed it over three work sessions, as it appeared in the Rappahannock Record on May 20, 2010, and as it is displayed on the county website. The projected fund balance for FY2010 is made with a high degree of certainty given there is only slightly more than one month of execution left in FY 2010. All FY 2010 revenue projections are based on current tax rates or, in the case of state and federal funds, the latest information available. Projected expenditures for FY 2011 reflect an increase of 1.5% in wages, salaries, and benefits for all full-time employees paid from County funds from the beginning of FY 2011.

the board has managed to keep the budget and tax rate the same as last year with a

fund balance of \$3.8 million. He recommends no change in the draft budget as

presented.

VIRGINIA JUVENILE COMMUNITY CRIME CONTROL ACT

WHEREAS, the General Assembly enacted the Virginia Juvenile Community Crime Control Act; and

WHEREAS, this Act provides for local governments to develop plans which set up a community-based system of services, programs and facilities for youth who have come before the Juvenile and Domestic Relations District Court; and

WHEREAS, the County of Lancaster has chosen to participate in the Act in a regional capacity along with the counties of Northumberland, Essex, Richmond and Westmoreland; and

WHEREAS, Lancaster County authorizes the Northern Neck-Essex County Group Home Commission (Bridge House) to serve as agent for the administration of these funds;

NOW, THEREFORE, BE IT RESOLVED THAT the Lancaster County Board of Supervisors endorses the local plan and by so doing, agrees to abide by the conditions established by the Virginia Juvenile Community Crime Control Act; and

BE IT FURTHER RESOLVED THAT the Lancaster County Board of Supervisors will participate in the Virginia Juvenile Community Crime Control Act and accept funds appropriate for the purpose set forth in this Act until it notifies the Department of Juvenile Justice, in writing, that it no longer wishes to participate.
