Because the demand and interest is so great they warn you that it may take a while to download. He was able to download the twenty-one day summary to see how Lancaster performed over the last cycle. They did not meet Adequate Yearly Progress (AYP) but remember that each year because the Virginia Standards of Learning exams are tied to "No Child Left Behind" the bar continues to get higher. By 2014 each school should have a 100%. He stated the 8th Grade Math that only 50% passed compared to 75% last year and 80% of the previous year passed. The passing rates for males were even lower and the fail rates amongst black students were higher at 54% compared to 35% last year and 27% the pervious year. He stated there were areas of improvement, however; these Math numbers stand out more. He stated the scores are available.

 <u>Request to Use School Operating Funds for Food Service Bills</u> – Mr. Larson presented a request by the Lancaster County Superintendent for Schools to utilize school operating funds to cover a temporary cash shortfall in the Cafeteria Fund.

Mr. Larson said this request for FY 2009 is consistent with the consideration given by the Board of Supervisors for FY 2008 and is the only reasonable alternative until a corpus of funds or reserve can be re-established in the Cafeteria Fund to cover costs incurred prior to revenues flowing. As stated by Ms. Sciabbarrasi, the school operating fund would be reimbursed for any "borrowings" made.

Mr. Jenkins asked how much is needed.

Mrs. Salg said the dollars amount is not available and the Armark bills have to be cleared out.

Mr. Larson stated the school board is moving in the right direction and the dollar figure is going down.

Mr. Jenkins made a motion to authorize Jack Larson, Financial Officer to transfer funds from the General Operating Funds to cover the temporary cash shortfall in the Cafeteria Fund.

 Lancaster Primary School Bus Loop – Mr. Larson presented a request by Superintendent of Schools to use unspent FY 2008 funds to complete the Lancaster Primary School Bus Loop.

Mr. Larson stated Ms. Sciabbarrasi's memorandum of August 21, 2008 was provided to Board members as an informational item only. Rationale for this is that guidance was given at the July 31, 2008 regular meeting that any requirement for funding to complete the subject project above already appropriated capital improvement funds would have to come from the school operating budget. Ms. Sciabbarrasi is correct in her assertion that use of FY 2008 funds that have lapsed or will lapse into the general fund balance must be formally considered separate and apart from last month's guidance which envisioned the use of current year funds.

Mr. Larson said while it does appear that there will be excess funds from the FY 2008 Schools Operating Budget after all accrued receivables and payables have posted, the amount is an estimate at this time and has not been subject to audit. If the Board should approve this request, then the amount approved should not exceed the amount requested or that available, whichever is less.

Mr. Geilich asked if this requires addition funding.

Mr. Larson said the funding was returned to the county and the county is simply re-appropriating the \$33,000.

Mr. Beauchamp made a motion to approve the use of unspent funds from the FY 2008 budget to complete the Lancaster Primary Bus Loop Project and the amount shall not exceed the amount requested or available, whichever is less.

4. <u>Virginia Public School Authority (VSPA) 2003D Return of Savings</u> – Mr. Larson said while at a training session, the Treasurer learned of a refund in the amount of \$92,922.18 due Lancaster County. To permit distribution of the funds, a resolution by the Board of Supervisors authorizing the execution of a Use of Proceeds Agreement and a Continuing Disclosure Agreement is required.

Mr. Larson stated there are two conditions associated with the funds to be returned. They must be used for capital projects of Lancaster County Public Schools, and they must be used within six months of receipt of the funds. Remaining expenditures for school projects approved for FY 2009 exceed the amount to be returned, and it is those projects to which it is recommended that the funds be applied rather than funds in the capital improvement account. It is anticipated that invoices will be submitted shortly for the majority of the work on these projects, necessitating expeditious receipt of the refund. The required Use of Proceeds Certificate and Continuing Disclosure Agreement were provided to the Board of Supervisors for their review.

Mr. Jenkins made a motion to adopt a Resolution authorizing the refund and execute the Use of Proceeds Certificate and Continuing Disclosure Agreement.

 <u>Final Draft – Architectural Contract to Design Judicial Center</u> – Mr. Pennell stated the Board of Supervisors earlier directed the county administrator and county attorney to develop a draft contract with Wiley and Wilson, Architects, to prepare the necessary design for the construction of the new judicial center.

Mr. Pennell said the document being provided is one that has been developed by the county attorney and his colleagues in lieu of utilizing the standard AIA (American Institute of Architects) contract. He has received advice from other county administrators that a locally developed contract is favorable to the AIA standard form and Mr. Cornwell agrees with this advice.

Mr. Pennell stated that recently, Jack Larson, James Cornwell and he met with representatives of Wiley and Wilson, Architects, to review this contract lineby-line. The Board of Supervisors has been provided with a draft copy of the contract as it was finally negotiated by the county staff, county attorney and architects.

Mr. Geilich said the target date for completion of the New Judicial Center is January 1, 2011.

 <u>Advertisement of Proposed Public Roadway Abandonment</u> – Mr. Gill presented a proposal to abandon 100.17 feet of public roadway at the end of VSH 721 (Railway Road) in Irvington in District 5.

Mr. Gill stated Kenmaur, LLC, the owner of Tax Map #33-269A, has requested this proposed abandonment and location of a new turnaround as depicted on the attached plat. Railway Road (VSH 721) comes to a dead end at Kenmaur's property with no public turnaround. An unauthorized turnaround currently being used is beyond the end of state maintenance sign and totally on Kenmaur's property, as evidenced by the attached real estate tax map. The other properties affected by this request, Tax Map #33-268 and #33-269, have their driveway accesses to Railway Road (VSH 721) prior to the location of the proposed turn around and would not be adversely affected. Mr. Gill said an easement for a turnaround exists on the adjacent parcel, Tax Map #33-268. Usage of that easement for a turnaround would be easier and safer, with the proposed road abandonment and new end of state maintenance, as vehicles would not have to negotiate that extra 100.17 feet of road and the curve while backing up to utilize the turn around.

Mr. Beauchamp made a motion to authorize the Director of Planning and Land Use to advertise a public hearing for the September 25, 2008 meeting of the Board of Supervisors to consider the abandonment of that portion of VSH 721 (Railway Road).
