PRESENTATION

1. YMCA Budget Review – Mark Favazza, Executive Director, Northern Neck Family YMCA introduced board members, Austin Roberts, Weston Conley, and Bill Lee. Mr. Favazza said with the new facility they have seen an increase in YMCA membership. The YMCA serves men, women and children of all ages, races, abilities, incomes and religions. The Guardian Program provides financial assistant those who are unable to participate due to their inability to pay the full membership or program fees. Some of the programs offered are aquatics, martial arts, school-age after school programs, summer camp, group exercise, family movie night at the Y, health and fitness programs, and sports. Unfortunately, the YMCA was unable to submit their budget request during the FY07 budget process, therefore; they are formally requesting for \$75,000. The Board of Supervisors has already approved \$50,000 and the YMCA is requesting an additional \$25,000 for this fiscal year.

property identified as Tax Map #5-29C. The subject property is off VSH 690, Norwood Church Road, near Morattico, Virginia in Voting District 1.

Mr. Larson said Mr. Felthouse wishes to place a singlewide manufactured home on the subject property. He is the contract purchaser of the property and will be required to close on the contract prior to issuance of permits. He has met all other requirements for consideration of this request.

Mr. Larson stated that advertising as required by law has been conducted and adjoining property owners individually notified of this public hearing. To date, there has been no input from either adjoining property owners or other interested members of the public.

2. <u>Application for Special Exception – R. Eddie Headley, Jr.</u> – Mr. Larson presented an application for special exception by R. Eddie Headley, Jr. to place a data antenna on property described as Tax Map #14A-2-3. The subject property is on VSH 201, White Chapel Road, Virginia in Voting District 1.

Mr. Larson said while placement of these antennas has been supported in the past as a means of extending high-speed internet access to citizens of the County, this request represent the first example of what could be a significant problem. Specifically, if approved, this antenna would be within a quarter of a mile of a competitor's antenna at the Upper Lancaster Rescue Squad building. As more providers compete to provide service, more requests for placement of these antennas can be expected. The proposed locations will inevitably be in close proximity because the selection criteria of high ground and potential customer base will be the same. Providers advise that sharing an antenna of the type is not possible.

Mr. Larson stated adjoining property owners have been notified and advertising conducted as required by law. To date, there has been no input from either adjoining property owners or other interested members of the public.
