VIRGINIA DEPARTMENT OF TRANSPORTATION

Mr. Pleva stated that no one was present from VDOT. He stated that a draft of the six-year plan had been included in the Board's package. He stated that the public hearing will be held at next month's meeting on December 12th.

PUBLIC HEARING

 Application for Special Exception-RAS Ventures, LLC c/o Ryan and Alison Adler

Mr. Lee asked Mr. Gill to present the issue.

Mr. Gill stated that the issue was an Application for Special Exception by RAS Ventures, LLC (Ryan and Alison Adler) to expand/enlarge an existing authorized non-conforming structure on a 0.47-acre parcel described as Tax Map #20D-5-503. He stated that the property is zoned R-1, Residential General and is located at 159 Bayview Drive in the Corrotoman by the Bay Subdivision in District 1.

Mr. Gill stated that the residential structure on this parcel existed prior to the effective date of the Lancaster County Zoning Ordinance and therefore is an authorized non-conforming structure. He stated that Article 12-4-1 allows for the expansion/enlargement of existing non-conforming structures with a special exception, if the setbacks of that zoning district can be met.

Mr. Gill stated that the applicant wishes to replace the existing one-story dwelling with a similar sized two-story dwelling. He stated that the replacement dwelling will not encroach further into the existing non-conforming 13.8' eastern sideyard nor the existing non-conforming 17.9' western sideyard, so no variance is required from the Board of Zoning Appeals. He stated that the replacement dwelling will conform to all other setback requirements of the R-1, Residential General District. He stated that the site plan verifies that the replacement dwelling conforms to the requirements of the Chesapeake Bay Preservation Act for redevelopment and mitigation of existing impervious cover within the 100-foot Resource Protection Area. He stated that the sole reason for this special exception request is that this authorized non-conforming structure is being enlarged from one-story to two-stories. He stated that many similar sized authorized non-conforming lots and structures exist in this neighborhood. He stated that the parcel's existing water and septic system will accommodate the replacement home.

Mr. Gill stated that adjoining property owners had been notified and advertising conducted as required by law and to date, there had been one call from an adjoining property owner who had no problem with the application.

Mr. Lee opened the public hearing.

There was no public input.

Mr. Lee closed the public hearing.
