He has incorrectly listed the in-kind items on Schedule B. They all fall in the filing period for the report due June 3, 2019 which handled the filing period of April 1, 2019 through May 30, 2019.

In conclusion, he owed you two reports, and he needs an incomplete notice for both of those reports to make the necessary corrections.
