

**VIRGINIA:**

A FY08-09 Work Session of the Lancaster County Board of Supervisors was held in the courthouse of said county on Wednesday, April 2, 2008.

**BUDGET CONSIDERATIONS**

**FY08 County Operating Budget**

Mr. Larson gave a summary of the current budget status.

**Commissioner of the Revenue**

Mr. Thomas recommended removing taxes on farm, machinery and livestock and stated there would be an estimated \$11,000 tax revenue loss.

Mr. Thomas asked the board to review the tax relief to elderly and handicapped and recommended beginning with \$20,000 income and assets to \$100,000.

Mr. Thomas asked the Board of Supervisors to reexamine the boat tax.

### **Circuit Court Clerk**

Mrs. Mumford requested that the board increase her budget by \$400.00 for additional postage and to keep part-time funding.

### **School Board**

Ms. Sciabbarrasi stated there would be a \$200,000 savings in Virginia Retirement System numbers. She is requesting a 1.5% step increase plus a 1% cost of living to be included in the budget.

Ms. Sciabbarrasi said the school board has asked for \$10,716,660 in local funding which is an increase of \$1,225,960 that is a 12% increase in local funding.

### **Sheriff**

Sheriff Crockett said that he was requesting an increase for communication. He also requested an additional \$2,017 to keep Victim/Witness in as a full program as the SRD Grant would offset the Victim Witness increase. He currently has four investigators and drug cases are increasing. He has submitted a draft budget request for four additional patrol deputies to provide for 24-hour law enforcement presence.

### **Emergency Services**

Chief Hudson made a presentation for increased funding for additional full-time hours and staffing.
