 <u>Northern Neck Soil and Water Conservation District</u> - Mr. Pennell introduced Derwin Booker, Northern Neck SWCD Director from Lancaster County.

Mr. Booker thanked the Board for the opportunity to make his presentation. Mr. Booker introduced Craig Brann, Conservation Specialist who will update the Board on past eleven months of progress.

Mr. Brann stated that last year's funded BMP acres were 1,253 and this year it has increased to 2,238 acres. He said the funding is available to erect 3,030 linear feet of fencing to help restrain farm animals.

Mr. Booker asked for the Board's support on the position paper before the VASWCD Association to reinstate funding for the SEAS program, expanding the BMP program for shoreline and consider reinstating the funding to NNSWCD in the amount of \$ 2,500.00.

VIRGINIA DEPARTMENT OF TRANSPORTATION

Mr. Balderson stated that the Taylor's Creek program is basically finished. The only thing remaining is to pave two areas of the road that connect near the church.

Mr. Balderson stated that the Blueberry Road speed limit signs will be erected this week.

Mr. Balderson stated the traffic study for Weems is almost complete.

PUBLIC HEARINGS

 <u>Application to Amend the Comprehensive Plan – Virginia Quality of Life</u>- Mr. Larson presented an application by Virginia Quality of Life to Amend the Comprehensive Plan to allow the extension of Kilmarnock water and wastewater treatment lines to the Wiley Childcare and Development Center. This facility is on property identified as Tax Map #28-110E which is on VSH 1036, Harris Road, near Kilmarnock, Virginia and is in Voting District 4.

Mr. Larson stated Planning Commission is forwarding this request recommending approval. Vote 6-0, 1 Abstention.

Mr. Larson stated that the purpose of this application is to provide municipal water and wastewater treatment hookups from the town of Kilmarnock for the Wiley Childcare and Development Center. As indicated in the minutes of the October 19, 2006 Planning Commission meeting, the application was supported by an adjoining property owner, other interested members of the public, and members of the Planning Commission. Advertising has been conducted as required by law and adjoining property owners (APOs) notified of this public hearing matter. To date there has been no input from adjoining property owners or interested members of the public.

Chairman Jenkins opened the public hearing.

Hearing no public comments, Chairman Jenkins closed the public hearing.

Mr. Russell made a motion to Approve the Application by Virginia Quality of Life to Amend the Comprehensive Plan to allow the extension of Kilmarnock water and wastewater treatment lines to the Wiley Childcare and Development Center.  Expansion of a Nonconforming Use – Donal Turkal/Sentry Associates - Mr. Larson presented a request by Sentry Associates to expand a nonconforming use, self-storage, by another 100 units on property described as Tax Map #34-404. This property is on VSH 3, Mary Ball Road, near White Stone, Virginia and is in Voting District 4. Staff recommends approval contingent on screening of all units.

Mr. Larson stated the conditional use, self-storage, approved on June 28, 1976 was for Tax Map #'s 34-403 and 34-404. As such, this request for expansion of the existing units on #34-403 to additional units on #34-404 can be made. The recommendation for approval of this request is based on what appears to be an unfilled need for these services and an opportunity to require screening for existing units in addition to those proposed. There is significant existing natural buffering that may be adequate to screen proposed storage units. However, the proposed screening on the front of the existing units should be wrapped around the property to provide total screening from VSH 3. Advertising as required by law has been conducted and adjoining property owners notified. To date there has been no input from adjoining property owners or other interested members of the public concerning this request.

Mr. Russell asked what type of screening would be required.

Mr. Larson stated mostly it would be Leyland Cyprus because of their quick growth rate. The new units will not be able to be seen since they will be constructed behind the old units. He stated that he suggested screening in the front and the edges of the property lines.

Mr. Geilich stated that on the plat given to the Board there is a label for an office and actually there is an office with living quarters for the supervisor of the

units. He also suggested that some attention be given to the sign in front of the units.

Mr. Turkal stated that the sign is being redone.

Mr. Russell stated that he does not understand the great need for storage.

Mr. Turkal stated that people need space to store stuff and the need for more units is needed at this time.

Chairman Jenkins opened the public hearing.

Hearing no public comments, Chairman Jenkins closed the public hearing.

 <u>Additional Funding – Virginia Department of Health</u> - Mr. Pennell stated that he has provided the Board members a copy of letter from Tom Bernard, Administrator, and Three Rivers Health District. In this letter, Mr. Bernard is soliciting an additional \$4,948.00 from the Lancaster Board of Supervisors to fund fiscal year 2006 Health Department operations in Lancaster County.

Mr. Bernard stated he was the new administrator for Three River Health District. He said the Board earlier this year Lancaster County allocated \$183,685 to the local health department for fiscal year 2006-07. This number was based on his best estimate of what state funding levels would be. The health department had to estimate those funds and as a result of an increase in state funding, Lancaster County allocation needs to be increased \$4,948.00 to support local Health Department operations.

Mr. Geilich stated that he was confused about some of the content of the letter.

Mr. Bernard stated that he could understand how confusing this can be. The Health Department's Budget is comprised of state funding and county funding. The amount of the State's contribution determines the County's contribution. The health department in early spring has to provide the State with its budget requests. The State determined that more money was needed from the county in order to receive the funding from the state, the county needs to provide more funding.

Mr. Russell asked if in order for the health department to receive funding from the state, the county needs to provide \$4,948.00 in additional funding.

Mr. Bernard stated that is correct.

Mr. Jenkins asked what the citizens of Lancaster County would get for this additional funding.

Mr. Bernard it is difficult to pinpoint a certain area where the funding would be used.

Mr. Jenkins asked so is it possible that none of the additional money would be used in Lancaster County.

Mr. Bernard stated that all the money would be used in Lancaster County.

Mr. Russell made a motion to Approve a Request by Tom Bernard, Administrator for Three River Health, for an additional \$4,948.00 from the Lancaster County Board of Supervisors to fund fiscal year 2006 Health Department operations in Lancaster County.

- Expansion of a Nonconforming Use Donahue Properties LLC Mr. Larson stated that Mr. Donahue asked to withdraw his request.
- <u>Town of Kilmarnock Boundary Line Adjustment</u> Mr. Pennell stated that the Lancaster county Board of Supervisors has had regular communication with the Kilmarnock Town Council over the past several months regarding the boundary line adjustment between the town and county.

Mr. Pennell stated that he provided all the Board members the proposed boundary line adjustment between Lancaster County and the Town of Kilmarnock includes the specifics of the joint Board/Council meeting on October 5, 2006. The current proposal, approved by the Town Council, takes in just enough land around the Kilmarnock Wastewater Treatment Plant to bring the facility into the Town of Kilmarnock. In addition, the part of the boundary line adjustment from old Oakwood Fitness Center to Irvington Road extends 400' deep along that side of Harris Road instead of the 200' originally proposed. He has discussed this most recent proposal with Mr. and Mrs. Warren Sellew, who are satisfied that their concerns have been addressed. They no longer oppose the boundary line adjustment as it appears in the Board's package.

Mr. Beauchamp stated personally he would like to see of four corners of Harris Road and Irvington Road to be included in the Boundary Line Adjustment.

Mr. Jenkins asked if we can include this addition into tonight's motion.

Mr. Pennell explained that the board cannot add anything more to the Boundary Line Adjustment but could decrease it. At the meeting the board need to decide on what is before them this evening. At a later date it can decide on additional areas.
