PUBLIC HEARINGS

1. Ordinance – Failure to File Personal Property, Etc. Forms – Mr. Pennell stated that at the November 29, 2001 meeting of the Lancaster County Board of Supervisors, he was directed to prepare and advertise an ordinance that would

impose a penalty for failure to file tangible personal property, machinery and tools, merchants' capital and mobile home reporting forms by May 1st each year.

Mr. Conaway made a motion to continue the public hearing for the Ordinance to impose a penalty for Failure to File Tangible Personal Property, Machinery and Tools, Merchants' Capital and Mobile Homes Reporting Forms until January 31, 2002 Board of Supervisors meeting.

Mr. Beauchamp made a motion to adopt the Ordinance to impose a penalty for Failure to File Tangible Personal Property, Machinery and Tools, Merchants' Capital and Mobile Homes Reporting Forms by May 1st of each year and add the wording on the form as follows:

AN ORDINANCE TO IMPOSE A PENALTY FOR FAILURE
TO FILE TANGIBLE PERSONAL PROPERTY, MACHINERY AND TOOLS,
MERCHANTS' CAPITAL AND MOBILE HOMES REPORTING FORMS
BY MAY 1 OF EACH YEAR

The Lancaster County Board of Supervisors hereby ordains the imposition of a penalty for failure to file Tangible Personal Property, Machinery and Tools, Merchants' Capital and Mobile Home Reporting Forms by May 1st of each year.

This Article imposes a penalty for not filing reporting forms for Tangible Personal Property, Machinery and Tools, Merchants' Capital and Mobile Homes by the May 1 deadline in any year. This penalty is at a rate of ten percent of the tax assessed or ten dollars, whichever is greater.

Requirement to File Returns. Any person having taxable personal property, machinery and tools, merchants' capital or mobile homes on January 1 of any year shall file a return thereof with the Lancaster County Commissioner of the Revenue in accordance with §58.1-3518 of the Code of Virginia (1950), as amended. Such returns shall be filed by May 1 of each year.

Notice to Taxpayers. The Commissioner of the Revenue shall ensure that the forms used to file a return of tangible personal property, machinery and tools, merchant's capital or mobile homes contains a statement notifying the taxpayer that failure to file the return by May 1 of each year will result in a penalty being imposed for the failure to do so.

Penalty for Failure to File by May 1 of Any Year. A penalty shall be assessed for any tangible personal property, machinery and tools, merchant's capital or mobile homes return filed after the May 1 deadline of any year. The penalty shall total ten percent of the tax assessed or ten dollars, whichever is greater. Any such penalty when so assessed shall become part of the tax.

Exceptions to the Assessment of a Penalty. Penalty for failure to file a return shall not be imposed if such failure was not the fault of the taxpayer. The responsibility to make the determination of fault shall be delegated to the Commissioner of the Revenue.

Extension of Time for Filing. The Lancaster County Board of Supervisors may provide for a reasonable extension of time, not to exceed ninety days, for filing returns on tangible personal property, machinery and tools, merchants' capital and mobile homes whenever good cause exists. A record of every such extension shall be maintained. If any taxpayer, who has been granted an

extension of time for filing his return, fails to file the return within the extended time, his case shall be treated the same as if no extension had been granted.

Authority. This Ordinance is adopted pursuant to the authority granted by §58.1-3916 of the Code of Virginia, (1950), as amended.

Effective Date. This ordinance shall be effective January 1, 2002.

2. <u>Douglas H. and Mary J. Ludeman – Request for Bay Act Waiver</u> – Mr. Larson stated the applicants was requesting a Chesapeake Bay Act waiver to allow an addition to an existing pool house to be placed with 25' of tidal waters. The property on which this would occur is described as Tax Map 333-204 which is located on Hayden Road near Weems, VA. This property is in Voting District 5.

Mr. Larson said the addition being proposed by Mr. and Mrs. Ludeman does not intrude any further into the Resource Protection Area than existing structures. The proposed combination of a French drain with dry well is considered an adequate Best Management Practice and will provide mitigation for the existing pool house/frame shed that does not presently exist. Computations show that there is no net increase in non-point source pollutants.

Mr. Larson stated that adjoining property owners have been notified and advertising as required by law has been conducted. As of this date, staff has received one phone call from an adjoining property owner requesting clarification of the scope of work within the application. The adjoining property owner stated

that she did not oppose the proposed effort provided that it was "done within the Ludeman's property."

Mr. Larson said staff recommends approval contingent on documentation supporting the claim of no net increase in non-point source pollutants.

Mr. Beauchamp made a motion to approve Douglas H. and Mary J. Ludeman's request for Bay Act Waiver.

WHEREAS, Lancaster/Northumberland Habitat for Humanity has started construction on a third home in Lancaster County; and

WHEREAS, Lancaster/Northumberland Habitat for Humanity has improved the living conditions for three partner families and continues to recruit more families; and

WHEREAS, Lancaster/Northumberland Habitat for Humanity homes have created responsible, home owner citizens and taxpayers for the counties.

NOW THEREFORE BE IT RESOLVED, that the Lancaster County Board of Supervisors recognizes the work of Lisa B. Butler, Charles J. Costello, Merle E. Peed, William H. Rowden, Sharon C. Fisher and Reuben E. Jackson who are charter members of the Lancaster/Northumberland Habitat for Humanity Board of Directors whose terms of office will be expiring soon because of the limits of the organization's by-laws; and

BE IT FURTHER RESOLVED, the Lancaster County Board of Supervisors recognizes the services of Matson C. Terry for providing legal advice to the Lancaster/Northumberland Habitat for Humanity; and

E. <u>Virginia State Parks – Best in the Nation</u>

COMMENDING VIRGINIA'S DIVISION OF STATE PARKS

WHEREAS, the Lancaster County Board of Supervisors has learned that the Virginia Division of State Parks has been recognized with the National Gold Medal Award as the best state park system in the United States; and

WHEREAS, this recognition was attained in spite of receiving the lowest financial support from state funding in the nation; and

WHEREAS, Lancaster County is honored and pleased to have Belle Isle State Park within its confines; and

WHEREAS, Belle Isle State Park was acquired by a well supported bond referendum in the early 1990's; and

WHEREAS, funding for infrastructure improvements to Belle Isle State Park were not included in the previous bond referendum; and

WHEREAS, the Commonwealth of Virginia's General Assembly is considering another bond referendum that will assist state parks.

NOW THEREFORE BE IT RESOLVED, by the Lancaster County Board of Supervisors that the Virginia Division of State Parks is to be commended for receiving the National Gold Medal for the best state park system in the United States; and

BE IT FURTHER RESOLVED, that the Virginia General Assembly is encouraged to consider favorably a bond referendum to provide infrastructure funding for the improvement of services in Virginia's State Parks; and

BE IT FURTHER RESOLVED, that the Lancaster County Board of Supervisors asks the Division of State Parks to use bond referendum proceeds to complete infrastructure elements as described in the Belle Isle State Park, Comprehensive Master Plan, specifically:

- Trails to island from car-top boat launch.
- Crabbing piers.
- Expanded maintenance area.
- A campground.
- A camp store.
- Swimming pool
- Archeological field school.

F. Resolution of Appreciation – 350th Anniversary Committee

3. Support Lobbying Efforts to Control Sludge Applications – Mr. Pennell stated he received a letter form the Northumberland County Board of Supervisors asking that Lancaster County participate in its efforts to retain the services of a lobbyist to support a bill proposed by Delegate Pollard to give local jurisdictions the ability to control where and when sludge is permitted to the applied to farmland. Northumberland County has obligated \$5,000 for this endeavor and is asking Lancaster County and the five other jurisdictions to participate.

By consensus of the Board of Supervisors, the county administrator is to invite Delegate Albert Pollard and Kenneth Eades to the January 31, 2002 meeting to discuss details of the proposal.

4. Health District Request for Unmatched Lancaster County Appropriation – Mr. Pennell stated he received a letter from Dr. Winter, Acting Director, Three Rivers Health District, asking Lancaster County Board of Supervisors to permit the district to retain \$11,433 in unmatched local allocation funds in its FY02 operating budget.

By consensus of the Board of Supervisors, the county administrator is to invite Dr. Winter to attend the January 31, 2002 meeting to provide greater detail about this request.

5. <u>Kilmarnock and White Stone Request to Review Redistricting</u> – Mr. Pennell stated he received a letter from Mayor Lloyd B. Hubbard, Jr., Town of White Stone and Mayor Edward J. Davis, Sr., Town of Kilmarnock asking the Lancaster County Board of Supervisors to meet with the town councils to discuss their concerns regarding the 2001 county redistricting and explore a mutually desirable resolution. While the redistricting is completed, it is possible for the Board of Supervisors to consider minor boundary line changes to their previously approved redistricting.

Mr. Pennell stated that any future meeting should include legal counsel to ensure that any proposed resolution is lawful.
